OVERVIEW

The CBL State Savings Bank Foundation administers a scholarship program designed to support the educational pursuits of high school seniors residing in Greenville and Spartanburg Counties, the communities CBL serves. This program reflects the Foundation's commitment to fostering future leaders in both the banking industry and the skilled trades that support our local economies.

APPLICATION TIMELINE

Scholarship applications will be accepted annually. All completed applications must be received by the close of business on March 1. If that date falls on a weekend, the deadline will shift to the preceding business day. Scholarship recipients will be selected and notified by May, with funds disbursed directly to the recipient's institution before the fall semester.

ELIGIBILITY CRITERIA

1. **High School Senior Status:** Applicant must be a high school senior graduating in the current academic year.
2. **Geographic Location:** Applicant must live in Greenville or Spartanburg County.
3. **Enrollment:** Applicant must be planning to enroll in a technical school.
4. **Skilled Trade Major:** Must plan to attend a technical school and pursue a skilled trade related to *commercial or residential real estate* (e.g., construction, plumbing, HVAC, electrical work, carpentry, welding).
5. **Academic Performance:** Applicant must have a minimum GPA of 3.0 on a 4.0 scale.
6. **CBL Relatives:** Relatives of CBL State Savings Bank employees and directors are not eligible to apply for this scholarship. This includes, but is not limited to, spouses, children, grandchildren, siblings, parents, nieces, and nephews.

APPLICATION REQUIREMENTS

1. **Completed Application Form:** All sections must be filled out accurately and completely.
2. **Personal Essay:** Submit a personal statement (500–700 words) that demonstrates your interest in a skilled trade specifically related to *commercial or residential real estate*. The essay must outline your career goals, describe your chosen trade (e.g., construction, plumbing, HVAC, electrical work, carpentry, or welding), and explain how this scholarship will help you pursue your education at a technical school and achieve your professional goals.
3. **Letters of Recommendation:** Submit two letters of recommendation from teachers, mentors, or employers who can attest to the applicant's character, work ethic, and suitability for a career in a skilled trade(s).
4. **Official High School Transcript:** Must include the most recent grades and GPA.
5. **Resume:** A current resume highlighting academic achievements, extracurricular activities, work experience, and community service.

SELECTION CRITERIA

Scholarships are awarded at the discretion of the Foundation's Board of Directors based on academic performance, community involvement, leadership, clearly defined career goals related to commercial or residential real estate, and alignment with the Foundation's mission.

APPLICATION PROCESS

1. **Submission Deadline:** All application materials must be submitted **by 5:00 pm on Friday, February 27, 2026.**
2. **Submission Method:** Applications can be submitted electronically via scholarships@myCBL.bank or mailed to 229 Trade Street, Greer, SC 29651.
3. **Notification:** Scholarship recipients will be notified by phone, email, or during their school's awards ceremony. Applicants who are not selected will not receive individual notification.

SCHOLARSHIP AWARD

1. **Amount:** The scholarship amount will be \$2,500.
2. **Number of Awards:** Up to two scholarships will be granted, with one scholarship awarded to each recipient.
3. **Disbursement:** Funds will be disbursed directly to the recipient's technical school to be applied towards tuition, fees, and other educational expenses.
4. **Renewal:** The scholarship is a one-time award and is not renewable.
